I am pleased to inform you that the forty-ninth Annual General Meeting (AGM) of HSBC Bank Malta p.l.c. (the "Company" / the "bank") is scheduled for Tuesday 13 May 2025 at The Mediterranean Conference Centre, Old Hospital Street, Valletta, Malta.

Shareholders registered on the Company's Register of Members as at 13 April 2025 have the right to attend and vote at the AGM. Shareholders eligible to attend and vote at the AGM may also appoint a Proxy.

It is important that you include your name and your Malta Stock Exchange number (MSE Number) in any correspondence related to the AGM.
